1 Executive Director's message



Throughout the past year, we've seen a significant upscaling of our strategy as we strive to extend our reach and provide more children with the opportunity to grow up in nurturing family environments. Our strategy is centred around the recognition of the pivotal role families play in children's lives, which has since been echoed by the UN General Assembly's mandate in 2019 to phase out institutional care in favour of community-based family placements.

Building upon the success of our work in China, we are now embarking on a mission to share our model globally. This ambitious undertaking meant we had to reassess how best to go about aiming to reform childcare services and prioritize family-based care. A key part of our new expansion strategy has been setting our sights on establishing regional hubs to expand our capacity to serve more countries, more efficiently.

In January, we ventured to Yerevan, Armenia, at the invitation of Minister Narek Mkrtychyan, laying the groundwork for potential collaborations across the Middle East. Our journey continued with a momentous signing of a Memorandum of Understanding in July at Kensington Palace, followed by a successful international Family Placement Conference in Yerevan in September to serve the South Caucasus and Middle East regions.

March saw us in Thailand, preparing for a national family placement media campaign where we set about raising awareness about the importance of family care. Our efforts culminated in a highly impactful press conference in April, garnering significant attention and support.

Similarly, our visit to Hanoi, Vietnam, reinvigorated our project there, leading to the establishment of a joint office with the Ministry of Labour, Invalids and Social Affairs (MoLISA). This progress has culminated in the selection of a new project site in Huế, a region with a particularly pressing need that we can begin to address in 2024.

September brought us to Hong Kong and Singapore, where we had the opportunity to screen the documentary 'Children of Shanghai' and make new connections. I'm pleased to announce that we have now established both a board of trustees as well as an office in Singapore, to serve the Singaporean community and bolster our fundraising efforts. I also had the privilege to return to the Ministry of Social and Family Development to discuss and give advice on family placement services.

Strategic planning meetings in Atlanta, USA, cemented our roadmap for the future, guiding our efforts to expand and innovate. This includes the use of 'My Family', our new digital and online training and resource tool that has the potential to scale up our project work globally in a much more efficient and effective way.

Looking ahead, our goal is to make 'My Family' a self-sustaining project in Singapore, that we can deliver to the Ministry of Social and Family Development to support their family care services. It can then be a model of best practice for new regional training and resource hubs that we intend to establish around the world. To achieve this, we must scale up our operations, human resources, funding capacity and develop new pilot projects in our hub countries. As I hope you can

gather, this is an exciting and dynamic time for *Care for Children*!

Thank you for all those who support this work, especially those who go un-noticed but give sacrificially. Together, I like to think of us a global family of our own, who appreciate the difference a warm loving family has on a child. We understand children that grow up outside of a family often develop attachment disorders relating to identity, self-esteem and the ability to form relationships. We can make a difference by establishing that the family unit is a pillar to society, crucial to the wellbeing of communities, and more importantly, necessary for giving a child everything they need to develop into who they're meant to be.

Model

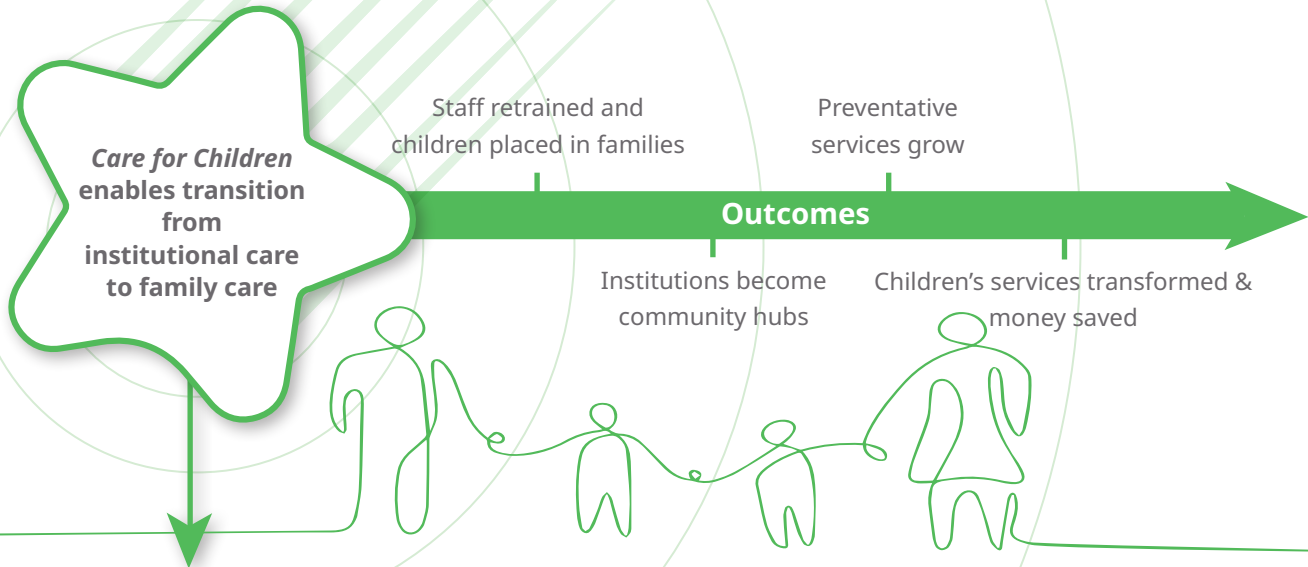

Stakeholders

1. Governments

Care for Children recognises a government's responsibility to protect its citizens. All of *Care for Children's* country projects are established and managed with an MOU at Ministry level, and implemented with local government.

2. Children

Care for Children focusses on seeing children in care moved into families as a positive alternative to institutions. All of *Care for Children's* work from government relations, to training, to fundraising, is shaped by reaching this goal.

3. Families

Care for Children recognises families as the real 'heroes' of family placement work, meaning their support is critical to the success of good, long-term placements. Prospective and experienced families are frequently involved in *Care for Children's* training activities, together with family care workers.

4. Family placement staff

Care for Children's professional approach is based on retraining institutional care staff to become family placement workers who are able to manage the transition of children from residential care into local families, with a particular focus on permanence. This is a specialist field of work within the alternative care spectrum, but the greater, indirect impact (i.e. theory of change) can lead to improved child welfare services and preventative measures for all children.

What is 'family care'?

'Family care' represents the specific type of long-term foster care that *Care for Children* promotes. Unlike general foster care, which provides temporary family life for children, *Care for Children's* 'family care' model **emphasizes permanence through secure, long-term placements**. This approach is similar to adoption in providing stability but includes ongoing support for families and monitoring by governments to ensure the children's well-being and the quality of care.

3 Track record

Orphanages were not only being emptied, but entire communities across China were being revitalized with purpose as the children filled the homes, schools, and playground anew.

From 1998, *Care for Children* supported the Chinese government to transition from an institutional care system to a family care model for orphans and vulnerable children. The government took on the responsibility for implementing family care, while *Care for Children* provided consultation and training, empowering government staff to ensure the quality and sustainability of the project.

Care for Children also provided technical support and seed-funding in the way of government matched family allowances (50%) to build models of best practice and design, and deliver a national family care training programme. This empowered the government to enact legislative support for family care in 2015, and by 2018 the Chinese bureau of statistics revealed that over one million vulnerable children were living in families instead of institutions.

Following invitations from a number of governments across Asia, *Care for Children* has also gone on to develop successful programmes with the governments of Thailand, Vietnam and Cambodia.

Asia Regional Team

In 2023, the Asia Regional Team (ART) remained steadfast in their commitment to advancing our mission in alignment with our new strategic directives. With a dedicated focus on enhancing training and project management across Southeast Asia, the ART played a pivotal role in driving impactful change. Made up of highly experienced social workers and child welfare professionals, our team has over 25 years of experience that is invaluable in guiding our new strategy to expand globally.

With the Cambodia team at full stretch, the task of developing the National Curriculum for Foster Carers was taken on by the ART. This document will serve as a manual and handbook for social workers for training family carers in the community. The document is expected to be completed by June 2024.

Throughout the year, the ART developed comprehensive training materials tailored to the specific needs of our active project sites. These materials were crafted in collaboration with local stakeholders, addressing crucial topics such as managing challenging behaviors in children and nurturing positive parent-child relationships. **Notably, their efforts culminated in the ongoing development of the foundation level training materials for our new digital tool 'My Family'**, designed to empower childcare practitioners and caregivers, and strengthen family dynamics within our communities. The team also finished the publication of insightful research papers delving into key areas such as family support strategies and the principles of attachment theory.

In line with our strategic vision, the ART's proactive involvement in project development yielded significant results, including a productive research visit to Vietnam and ongoing review of the partnership agreement with the government. Internationally, their presence resonated at the South Caucasus and Middle East Family Placement

Conference in Armenia, where they leveraged their 25+ years of combined experience to impart invaluable insights on supporting families, assessing prospective foster families, and navigating the complexities of child welfare systems. Their participation not only showcased their expertise but also reaffirmed our commitment to fostering cross-cultural collaboration and knowledge exchange.



Achievements

Thailand

When you understand that something is beneficial and will positively impact the lives of children and families, it makes you eager to share it. That is how *Care for Children's* Thailand team felt in 2023 and the reason why much of their work throughout the year focussed on raising greater awareness about family care. At the beginning of the year, under the banner of "A Shared Destination: A Caring Family for Every Child", our government partners and like-minded NGOs came together to shed light on the strengths, opportunities, and challenges of providing family-based care for orphans and vulnerable children.

Following on from this, *Care for Children* and the Department of Children and Youth (DCY) jointly launched a national campaign to raise awareness of family placement to recruit more foster families. The campaign marked the 10-year milestone collaboration between DCY and *Care for Children* in Thailand, and by engaging with both traditional media and social media influencers, we are excited to report that **we reached over 1 million people with the message of family care**. It was a wonderful opportunity to highlight how children have been thriving in family care and to reach out to the broader Thai community inspiring them to open their homes to change the lives of more vulnerable children. We are delighted that there is now a push from the government that every province in Thailand should work towards recruiting and registering family carers.

Vietnam

2023 saw a number of breakthroughs with the Vietnam project, as we continued to advocate for children being able to grow up in secure and loving families.

Over the course of 2023, the Vietnam Project organized three introductory workshops to family care across three provinces including Phu Yen, Thua Thien Hue and Binh Duong for 45 participants, including governmental leaders and child protection officers. The workshop introduced the core elements of *Care for Children's* family care model and how it supports the government in its transition from institutional care to family care. *Care for Children's* Vietnam team and Asia Regional Team also visited a number of Social Protection Centres, or orphanages, to assess potential new project sites. After extensive consultation with multiple stakeholders, Huế in central Vietnam was selected as a new project site.

Throughout the year, the Vietnam project team conducted training need assessments through focus group discussions and in-depth interviews with Huế local authorities, Huế, Social Protection Centre and relevant stakeholders. Based on the data, the team is designing a tailored training programme that suits the needs of every government agency involved in the family care process.

In another milestone for the Vietnam project, **the Vietnamese government approved a significant new policy that saw family care become the government's preferred method of child care, stating that all children must be in family care by 2030**. This new policy reflects significant changes to the child welfare system and a commitment from the Vietnamese government to allocate resources that prioritize family care over other alternatives.

Moving towards this vision of all children in Vietnam in families, *Care for Children* has been working with the Department of Children Affairs to develop an action plan for the next four years.

Cambodia

Significant progress has been made in supporting the Cambodian government's shift from institutional care to family-based care for orphans and vulnerable children in 2023; focusing initially on supporting two Residential Care Institutions (RCIs) to develop family placement programmes. Needs assessments were conducted with the two RCIs - in Phnom Penh and Siem Reap - leading to the development of a comprehensive training schedule that commenced in late February. This training encompassed the entire process of assessing families, safely matching and placing, monitoring, and supporting a child in a family. We received positive feedback from trainees for its depth, as well as its interactive and practical nature.

Ongoing discussions throughout the year with the Ministry of Social Affairs, Veterans and Youth Rehabilitation (MoSVY), *Care for Children's* governmental partner, led to their agreement to propose a change in government policy allowing RCI staff to become family placement support workers. This is a key development in the project, ensuring that the same staff members can assess and prepare children for placement within the RCI and also support them once placed in families. Additionally, **the government has agreed to support family placement allowances during this pilot phase**, a major development in the transformation of Cambodia's family care system.

Active casework began in July, focusing on preparing children for placement into families, with technical support sessions enabling staff to put into practice the knowledge they gained from workshops. **The highlight of this year was the placement of the first child from a government RCI into a family in Siem Reap, marking a significant milestone.** Placing the first child can often be the most challenging step. We hope that this will be a tipping point in the development of Cambodia's child welfare system, with momentum continuing to see many more children placed into families.

I can see that attachment is the foundation of healthy development for children. Love, care and other basic needs are important but even more important is having an example to see how life in a family environment can be like.

5 Significant events & developments



Following the Memorandum of Understanding that was signed in July 2023, Care for Children took significant strides towards establishing a hub in Armenia that will be able to serve the Middle East and South Caucasus regions. These efforts culminated in the South Caucasus and Middle East Family Placement Conference, co-organized and co-hosted by the Republic of Armenia Ministry of Labour and Social Affairs and Care for Children.

Mr Narek Mkrtchyan, the Armenian Minister of Labour and Social Affairs, graciously hosted and opened the conference. We were honoured to have Lord Laming join us online to deliver a welcome speech, with Mr Edward Timpson CBE KC MP providing additional insights with his keynote speech. Their contributions significantly enhanced our reach and diplomatic efforts, underscoring the importance of international collaboration in advancing family care initiatives.

It brought together over 200 participants including international and local experts, government officials, childcare practitioners, NGOs and government representatives including Lebanon, UAE, Syria, Iran, India, Vietnam, and Cambodia.

This first-of-its-kind conference was a platform for sharing knowledge and international best practices, and highlighted the global importance of family placement and family care. Delegates expressed hope and enthusiasm for the continued development of Armenia's family care program, with this sentiment echoed by many of the visiting international delegations. **We hope this extraordinary gathering will cement existing relationships while opening doors to many exciting new opportunities across the region.**

We would like to extend a special thank you to our partners in the Armenian government for their unwavering dedication and strenuous efforts in ensuring the successful execution of the conference amidst the heightened political tensions affecting the region at the time.

6 Reflections from the field

Cambodia

*We had a really encouraging meeting with the social workers who placed the first child into a family with our support, and it's been so encouraging to hear how he's getting on and settling in, and how they're supporting him. They talked also about the change that they're already seeing in him. Just within a month of living in a family, they're saying that **he is happier, he's smiling lots, he's playing whereas he wasn't allowed to play before. He's making friends at school, and he's reaching out to the family carers to help meet his needs.** Whereas before he had to depend on himself.*

These are all massive changes for the child and are really impacting his day-to-day quality of life. It makes my heart so happy. It's been great to hear from the social workers as well about how they've learned in the process, and also how they're just so happy to see how he's doing and the changes that they

see in him, because obviously they knew him in the RCI (Residential Care Institution). To be able to take him out of the RCI and put him into a family is just a dream. I think it's really helped as well for them to see how the process works - from completing our training to actually implementing it in practice and seeing how it really impacts a child's life. That's been so encouraging for us and so exciting.

We know there will be challenges along the way, and that there is a lot of adapting for both the child and the foster carers, but this is a really promising start. We strongly believe that with the ongoing support and monitoring from government social workers, these can be worked through together with the child's best interests at heart.

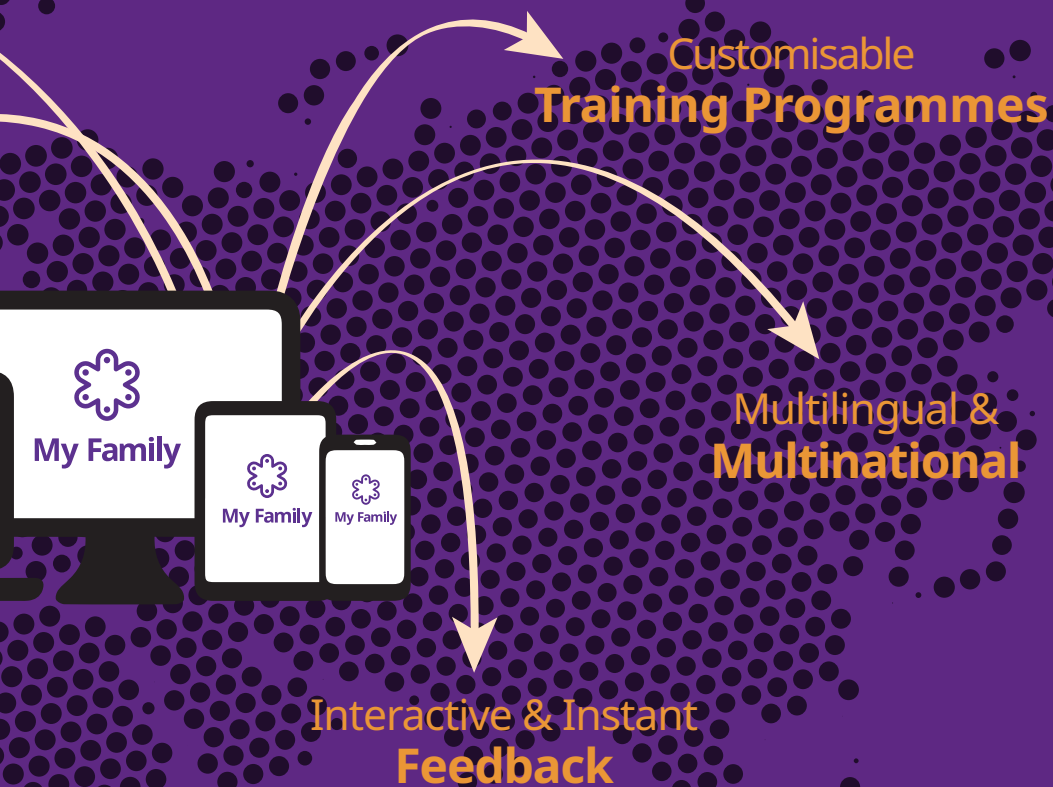

It empowers us to maintain the highest international standards in child welfare reform while offering cost-effective and efficient strategies for our teams worldwide.

This is a crucial part of our new strategic plan, that focuses on establishing regional hubs in strategic locations around the world. It will allow us to deliver our training more easily into different countries by overcoming geographical barriers, making it easier and quicker for practitioners and families to grasp the responsibilities, challenges, and rewards involved in offering a home to orphans and vulnerable children.

Our Asia Regional Team has been leveraging their many years of experience with the success of the China project to develop training materials for *My Family*. Their expertise will prove invaluable when tailoring culturally specific training materials, which is key to ensuring the highest standard of training is delivered.

Looking ahead, we are preparing to trial *My Family* in Thailand. **We will be leveraging its capabilities to enhance our ongoing training programs, and to assess the efficacy of the platform as a training tool.** Should this prove a success, we hope to deliver the final product to the Singapore government, which will help support their commitment to seeing two-thirds of all children in care placed into loving, local families.

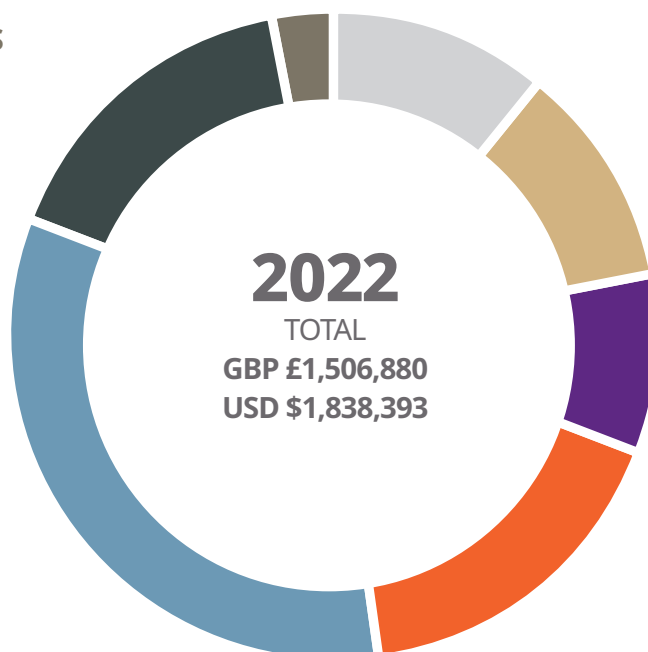
