Reports to: This role will report to and work under the overall guidance of the Country Manager.


#### II. Key Objectives of the Position

#### Build relationship with project partners

- · Meet with project partners, inform them about project trajectory, roles, responsibilities of different stakeholders, ownership, governance and project budget
- · Build close and constructive relationship with Care for Children's project partners at project sites and actively identify the most effective approach to promote the implementation of family care
- · Closely coordinate with local government for smooth and successful project implementation
- · Work with various stakeholders towards the goal of placing children from residential care into local families
- · Communicate effectively Care for Children's vision, mission, model and approach to work in ways that are contextually appropriate and clear





## Build partner's capacity in implementing Family Care

- · Assist the Training Team in developing Care for Children's training program for the Vietnam project
- · Support the delivery of trainings and technical meetings
- · Support local foster care practitioners when and where needed
- · Work with Care for Children's global team to translate, write and produce contextualised training materials that are in accordance to the laws, regulations and culture of Vietnam

### Project planning and implementation

- · Support project partners to form groups (workforce) on the implementation of Family Care
- · Facilitate to conduct various capacity building activities with project partners to equip them with knowledge and skills in family care
- · Facilitate to conduct workshop, meetings, coaching sessions based on the needs of project progress
- · Carry out baseline and project date to inform project approach and methodology


